<ul style="list-style-type: none"> <li>➤ Contractor shall ensure that all utilities (water, sewer, electric, gas) are disconnected prior to demolition.</li> <li>➤ Contractor shall ensure and is responsible for the removal of all structures, contents, foundations, light posts, underground equipment/structures, fences, trash, debris, etc.</li> <li>➤ All material shall be hauled and disposed of at an approved off-site facility outside the city limits.</li> <li>➤ This permit becomes null and void if work or construction authorized is not commenced within 180 days, or if construction or work is suspended or abandoned for a period of 180 days at any time after work is commenced.</li> <li>➤ I hereby certify that I have read and examined this application and know the same to be true and correct. All provisions of laws and ordinances governing granting of a permit does not presume to give authority to violate or cancel the provisions of any other state or local law regulating construction or the performance of construction.</li> </ul>
