**THE FOLLOWING MUST PASS FOR EACH MOBILE HOME IN PARK PRIOR TO PERMIT ISSUED**  
**Inspector may find other items not listed on this checklist and may need to be addressed**  
*(This form must be completed for each Mobile Home)*

- \_\_\_ 1. Keep all roads repaired free of pot holes and cracks properly sealed
- \_\_\_ 2. Non – skirted trailers shall be skirted at all times. All mobile homes shall have tie downs.
- \_\_\_ 3. Trash shall be contained, at all times, out of yards and MH Park
- \_\_\_ 4. Dumpster enclosure is required to be screened on three sides and properly maintained
- \_\_\_ 5. Junk, debris, furniture, mattress, nor junk vehicles shall not be allowed in any part of the park and shall be addressed and removed by owner; on a daily basis
- \_\_\_ 6. Parking in yards shall not be allowed! All parking shall be on paved area
- \_\_\_ 7. Each Mobile Home shall have an address displayed on the street side with 6 inch numbers/letters
- \_\_\_ 8. Each Mobile Home electrical connection shall have an electrical disconnect and shall be numbered. The pole shall not be broken or loose and shall be grounded properly
- \_\_\_ 9. HVAC unit each Mobile Home and Office shall be equipped with HVAC and Hot Water
- \_\_\_ 10. All broken windows and doors shall be addressed on a daily basis without delay
- \_\_\_ 11. All water heater room doors shall close properly
- \_\_\_ 12. Each and every stairway for mobile entry and exit shall be equipped with a stairway and maintained at all times
- \_\_\_ 13. Keep electrical service line clear of tree limbs and vines
- \_\_\_ 14. Broken lights need to be replaced and working at all times
- \_\_\_ 15. All Mobile Home mailboxes must be addressed
