Sealed bids will be received by the City of Stephenville, at City Hall, 298 W Washington Street, Stephenville, TX 76401 until 2:00 pm, Tuesday, September 20, 2022, at which time bids duly delivered and submitted, will be considered for:

ANNUAL CONTRACT FOR JANITORIAL SUPPLIES

Bids should be addressed to Tricia Wortley, Purchasing Manager, 298 W. Washington, Stephenville, TX 76401.

Any bid received after stated closing time will be returned unopened. If bids are sent by mail to the City, the bidder shall be responsible for actual delivery of the bid to the City Secretary before the advertised date and hour for opening of bids. If mail is delayed either in the postal service or in the internal mail system of the City of Stephenville beyond the date and hour set for the bid opening, bids thus delayed will not be considered and will be returned unopened.

Until the final award by the City of Stephenville, said City reserves the right to reject any and/or all bids, to waive technicalities, to re-advertise, to proceed otherwise when the best interest of the City will be realized hereby. Bid award is not solely based on price alone.

All bids must be submitted on original bid forms. Any changes to the form or failure to label packaging on the bid, may disqualify it. All packaging on bids (including courier envelope) will be submitted sealed and plainly marked with:

It is not the intent of the City of Stephenville to offer proprietary specifications, or to eliminate any vendor from bidding by the use of brand names. If brand names are used it is for example only and understood the "or equal" will be accepted.

Bids shall be held firm for a period of 60 days unless otherwise stated in the bid specifications, instructions to bidders, or on the bid sheet.

STANDARD INSTRUCTIONS TO BIDDERS

Bids that contain any omission, erasures, or alterations, or additions of items not called for in the bid documents, or irregularities of any kind, may or may not be considered.

Deviations from specifications and alternate bids must be clearly shown on the bid form with complete information attached to form. They may or may not be considered.

Upon bidders submitting bids they shall not withdraw or cancel such bids and all sums deposited with such bids will be held by the City of Stephenville until all bids submitted shall have been canvassed and award of contract made, signed and if a performance bonds is required furnished and approved. All sums deposited with bids will then be returned to the respective bidders.

The City of Stephenville, Texas is exempt from State of Texas Sales Tax and a Tax Exemption Certificate shall be furnished by the City of Stephenville, Texas to the successful bidder upon request.

No employee of the City of Stephenville shall have financial interest, direct or indirect, in any contract with the City, or be financially interested, directly or indirectly, in the sale to the City of any land, material, supplies or services.

Discounts: Show rate, total amount, and latest day any discount will be allowed after receipt of article and correct invoice.

This contract is subject to cancellation upon thirty day written notice by the City of Stephenville without cause.

Liquidated Damages: In the event delivery is not made within the stated time period, (without acceptable reasons for delay and written consent from the City) the City reserves the right to place the order with the next available vendor and the awardee shall be liable for any increase in price as liquidated damages, it being agreed that said sum is a fair and reasonable estimate of actual damages the City will incur. Bidder will not be held liable for failure to make delivery because of strikes; conscription's of property, governmental regulations, acts of God, or any other causes beyond his control; provided an extension of time is obtained from the Division of Purchasing.

Exceptions: Any catalog or manufacturer's reference in this proposal is descriptive, but not restrictive, and is used only to indicate type and grade. Bids on other items of similar and equal quality will be considered, provided the bidder states on the face of this proposal exactly what he intends to furnish, including any variation to the specifications and literature, otherwise he shall be required to furnish the items as specified on the proposal. Any other exceptions to any portions of these terms and conditions or deviations from written specifications shall be shown in writing on the bid document form or attached to bid form.

Quantities: Quantities shown are estimated, based on projected use. It is specifically understood and agreed that these quantities are approximate and any additional quantities will be paid for at the quoted price. It is further understood that the supplier shall not have any claim against the City of Stephenville for quantities less than the estimated amount

Prices: The bidder should show in the bid document both the unit price and total amount, where required, of each item listed. In the event of error or discrepancy in the mathematics, the unit price shall prevail.

Delivery Date: Bidders shall state delivery date on all order.

F.O.B Point: All prices of item(s) shall be quoted FOB City of Stephenville destination.

STANDARD INSTRUCTIONS TO BIDDERS

It is desirable that bids are accompanied by two sets of specifications to support items bid. The City of Stephenville reserves the right to determine specification requirements on all items bid.

Eligible Bidder: Bidders are limited to those persons or firms qualified and engaged in a full time business and can assume liabilities for any performance or warranty service required.

Nonresident-Reciprocal Bid Act: You are advised the City of Stephenville, Texas is bound by House Bill 620. The law provides that in order to be awarded a contract as low bidder, non-resident bidders (out-of-state contractors whose corporate office or principal place of business is outside the State of Texas) bid projects in Texas at an amount lower than the lowest Texas resident bidder by the same amount that a Texas resident bidder would be required to underbid a nonresident bidder in order to obtain a comparable contract in the state in which the non-resident's principal place of business is located. After making that determination you are instructed to advise the Purchasing Department in writing of that fact with a copy of the applicable state statute.

Based on local government code 252.043, the contract will be awarded to the lowest responsible bidder *OR* to the bidder who provides goods or services at the best value for the municipality. Therefore price is not the only consideration in the bid award.

By signing this bid, Vendor hereby certifies that it is not a company identified on the Texas Comptroller's list of companies known to have contracts with, or provide supplies or services to, a foreign organization designated as a Foreign Terrorist Organization by the U.S. Secretary of State. Vendor further certifies and verifies that neither Vendor, nor any affiliate, subsidiary, or parent company of Vendor, if any (the "Vendor Companies"), boycotts Israel, and Vendor agrees that the Vendor and Vendor Companies will not boycott Israel during the term of this Agreement. For purposes of this Agreement, the term "boycott" shall mean and include terminating business activities or otherwise taking any action that is intended to penalize, inflict economic harm on, or limit commercial relations with Israel, or with a person or entity doing business in Israel or in an Israeli controlled territory.

CITY OF STEPHENVILLE REQUEST FOR BID - JANITORIAL SUPPLIES

INTRODUCTION

This Request for Bid sets forth the specifications and requirements for the purchase of janitorial supplies for use by all departments within the City of Stephenville jurisdiction.

SPECIAL TERMS AND CONDITIONS OF THE CONTRACT

I. CONTRACT TERMS:

- a. Length of this price agreement shall be for one (1) full year, starting October 1, 2022 and ending September 30, 2023. Prices must remain firm for the entire contract.
- b. The City reserves the right to renew the contract for an additional two (2) years, not to exceed one (1) year per renewal.
- c. Purchases will be made on an as needed basis.
- d. Bid will be awarded on an all-or-nothing basis, not per item.
- e. There will be no minimum amount requirements on orders placed.
- f. Items ordered will be delivered by next business day.
- g. Purchase order numbers will be issued on a monthly basis, and shall cover all purchases for the designated month.
- h. Freight and inside delivery will be at no charge to the City. All prices quoted shall be F.O.B. destination, Stephenville City Hall or any other designated City locations, per Exhibit A. This list of locations is subject to change.
- i. No restocking fee will be charged for returned items.
- j. Price discrepancies on monthly statements will require a credit memo to be issued within 30 days.
- k. When using the Vendor's products, vendor will supply and install all soap and towel dispensers at no cost to the City.
- I. Vendor must have an online ordering system or a telephone contact number that is answered by a live person during normal business hours.
- m. Vendor must be able to supply upon request, usage reports by total spent and product groups for specific time frames (month, year, etc.).
- n. City of Stephenville reserves the right to cancel this agreement upon 30 days written notice with good cause.

II. EVALUATION CRITERIA

Award shall be made to the bidder that provides the best value for the City. It is not the policy of the City of Stephenville to award a bid on the basis of price alone. Evaluation of the bidder shall include, but is not limited to the following:

- a. Unit price
- b. Ability to deliver next business day
- c. Quality of Products evaluation of alternates or equivalents

- d. Probability of continuous availability on products
- e. Vendor reliability

III. BRAND NAME REFERENCES

- a. Any catalog, brand name or manufacturer's reference used is considered to be descriptive, not restrictive, and is indicative of the type and quality the City desires to purchase. Name brands are for reference only. Bids on similar items of like quality will be considered if the bid is noted and full description is provided.
- b. If notation of substitution is not made, it is assumed vendor is bidding on the item specified.
- c. Successful vendor will not be allowed to make unauthorized substitutions after award. Substitutions due to supply issues, must be submitted in writing to the City of Stephenville for approval. Subsequently if authorized substitutions are made on orders, original bid price or substituted item cost will be used, whichever is lower.
- d. If alternate brands are bid, samples may be requested by the Purchasing Department. The City has the right to examine all products and determine if they are of equal quality as the item specified.

IV. PRICING INSTRUCTIONS:

- a. Suppliers must submit pricing on the original Bid Price Sheets provided in the specifications. The fixed price provided must be for the exact unit of measure stated on the Bid Price Sheet. Bidding product via unit of measure conversion is not permitted.
- b. One (1) price only will be considered for each item. When two (2) prices are bid, both will be rejected.
- c. Errors in Bids: When an error is made in extending the total price, unit price will govern. Erases in bids must be initialed by the bidder. Carelessness in bidding pricing or in preparation of bid otherwise, will not relieve the bidder. Bidders are cautioned to recheck their bids for possible errors. Errors discovered after public opening cannot be corrected and the bidder will be required to perform if his bid is accepted.
