ADDENDUM NUMBER ONE RFP 3045 – Tree Maintenance Services

Vendors have emailed questions in for clarification on the Tree Maintenance Services RFP. We are making the responses available for all bidders below.

1. Will the City always require an ISA Certified Tree worker and Arborist on-site while work is being performed?

Not always.

2. Are gas-powered blowers allowed in the city?

Yes.

3. Will traffic control plans be required? If so, how will this be charged?

4.7 (k) - No compensation will be made to the Contractor for work and materials involved in maintaining barricades, signs, pavement markings, warning devices and lights, nor for providing any other incidental items necessary for traffic control which employs the use of the City's Traffic Code. However, for non-standard traffic control where a signed and sealed Traffic Control Plan is deemed required by the City, the Contractor shall utilize a State of Texas licensed professional Engineer to prepare a signed and sealed Traffic Control Plan, approved by the Director of Public Works, prior to commencing work. Copies of invoices and payment supporting actual costs are required to be submitted by the Contractor. The City will not provide compensation without submission of invoices and payment supporting actual cost.

4. Will there be a site provided for parking of vehicles & equipment and/or staging of materials?

Parking/staging will depend on the location but will be provided as needed.

5. What firm had the previous contract for tree maintenance?

This is the first time we have bid this contract. No previous information is available.

6. Can the bidders obtain a copy of the most previous Agreement including price schedule?

This is the first time we have bid this contract. No previous information is available.

7. Is the Contractor required to collect a new inventory as part of this contract?

8. Is Park tree maintenance included under this RFP?

9. Will the contractor be allowed to request an annual cost adjustment based on the Consumer Price Index?

- 11. For work performed more than 8 hours and/or work performed on weekends or Holidays, how will this be charged? There is no line item for this.
- 4.7 (a) The Contractor shall only work Monday- Friday between the hours of 8:00 a.m. and 5:00 p.m. and shall follow the City of Stephenville's holiday schedule unless prior approval is obtained in writing from the City. The Contractor shall confirm the work order location(s) with the City between the hours of 8:00 a.m. and 9:00 a.m. at the beginning of each work week via email.
- 12. What is anticipated annual budget for this contract?

We do not have an anticipated budget.

13. If no anticipated budget, what were expenditures for the last calendar or fiscal year?

We have an estimated average of \$20-25K per year.

- 14. How is work appropriated or assigned?
- 4.6 (a) The Contractor shall be notified of a work order by email. The Contractor shall confirm via email receipt of the work order within one (1) business day of notification being sent. The services described on the work order shall be completed within the time period specified in the work order and agreed upon by both the City and the Contractor.
- 15. How is work scheduled throughout the year?

Work is scheduled as needed.

16. Who from the Agency assigns the tree work, trimming, removals, etc.?
